### **Description of Position:**

*The PVE Beach Commissioner is responsible for all matters relating to Beach ParaVolley and Beach Sitting Volleyball within the PVE Zone, including the promotion of Beach events within the PVE Zone, the preparation of an international calendar of Beach events within the PVE Zone, all matters related to technical officials and technical equipment in coordination with the WPV related Commissions and the updating of the PVE beach rankings.*

*The PVE Beach Commissioner shall be appointed to the WPV related commission for beach paravolley coordination.*

### **Reporting and Working Relationships:**

*The PVE Beach Commissioner reports to the PVE Sports Director and PVE General Manager.*

*The PVE Beach Commissioner may propose other members to form part of the Beach Commission to the PVE Sports Director (if required)*

*The PVE Beach Commissioner works in co-operation with the PVE Sports Director, the PVE Competitions Department, the PVE Beach Commission members and the local organising committees of international competitions.*
